YEAR 10 WORK EXPERIENCE PROGRAM 2024

All Chancellor State College Year 10 students are encouraged to attend a work experience placement in the last week of Term 4, Monday 18 to Friday 22 November 2024.

Work experience provides a formal arrangement, approved by the Minister for Education, where students, can participate in activities in a place of work while enrolled in school. This experience assists students in their transition from school to work and with setting their career goals.

The work experience program aims to:

- Provide opportunities for students to sample or try industries identified as possible career pathways from their Senior Education and Training (SET) Plan;
- Provide students with an opportunity to relate school studies with workplace contexts;
- Prepare students for the demands and expectations of the working world;
- Help students make informed career decisions by assessing their aptitudes and interests, and exploring potential careers;
- Familiarise students with non-gender-stereotyped occupations;
- Give students an insight into the diversity of employees in the workplace;
- Improve students' maturity, confidence and self-reliance;
- Provide a link between the College and local community;
- Provide students with appropriate knowledge, skills and attitudes concerning both paid and unpaid work;
- Potentially lead to part-time employment either after school, weekends or during the holiday period;
- Provide an opportunity to extend theoretical learning in the classroom into practical applications of the workplace.

A work experience provider may be a person, company, business, association, local authority or any other body, able, in the opinion of the principal, to provide work experience. Students will be placed for a full week. The insurance cover for work experience students has certain restrictions and activities precluded from cover, and these activities may not be undertaken during work experience. Students who do not participate in the Work Experience Program are expected to attend school as normal and will engage in an alternate program of study focusing on similar outcomes as the work experience program or other similar learning opportunities.
